AFGHANISTAN: IN 2021 OUR PARTNER, WAR CHILD UK, FORMULATED AN EMERGENCY RESPONSE PLAN TO PROVIDE IMMEDIATE SUPPORT TO FAMILIES WITH URGENT FINANCIAL, PROTECTION AND EDUCATIONAL NEEDS. A LIFELINE AT TIMES OF CRISIS, THE CHILD HELPLINE IMPROVES MANY FAMILIES AND COMMUNITY MEMBERS' ACCESS TO CHILD PROTECTION SERVICES AND ALLOWS TEAM MEMBERS TO QUICKLY IDENTIFY AND REFER ANY CASES WHERE CHILDREN HAVE BEEN EXPOSED TO VIOLENCE, ABUSE, OR HARM.
